

**NRA REGISTERED 2700 PISTOL MATCH**  
**SPONSORED BY THE ILLINOIS STATE RIFLE ASSOCIATION**

**WHO MAY COMPETE:** All National Rifle Association members

**LOCATION OF RANGE:** Approximately 10 miles west of Kankakee, Illinois on Warner Bridge Road, north of Illinois State Route 17.

**REGISTRATION FEE:** \$8.00, \$5.50 of it is paid to the NRA.

**ENTRY FEE:** \$2.50 per match. Shoot the works, \$45.00 which includes registration fees. Advance entry fee received 7 days before the match date is \$40.00. Match entries canceled by the day before the match date will receive full refund. Make checks payable to: ISRA Conventional Pistol Committee.

**ENTRIES:** Entries will be limited to 50 competitors. One (1) relay. Shoot the works entries will be given preference.

**TIME:** Registration begins at 8:00 a.m. Firing begins at 9:00 a.m. There will be a 20 minute break between the 22 caliber and centerfire matches. There will be an one (1) hour lunch break between centerfire and the 45 caliber matches.

**RULES:** Current NRA rules for outdoor pistol competition will govern this match. Competitors will score and change targets. Bring your stapler.

**CHALLENGES:** Challenge fee is \$2.00. Time limit will be one hour after scores are posted. The plug-type scoring gauge will be restricted to use by range personnel only.

**CLASSIFICATION:** NRA classification system will be used. Unclassified competitors will fire in the master class.

**CATEGORIES:** Competitors will not be separated into categories.

**FACILITIES:** 50 firing points, controlled by loudspeakers. Line is poured concrete and covered. Targets are electrically operated. Potable water and restrooms are available at the range. Lunch will not be served at the range. A restaurant is located about 1 ½ miles from the range.

Match 1. 22 caliber, 20 shots, SF @ 50 yards, B6 target

Match 2. 22 caliber, 30 shots, NMC (10shots SF@50 yards, 10shots TF @25 yards, 10 shot RF @ 25 yards)

Match 3. 22 caliber, 20 shots, TF @ 25 yards, B8 target

Match 4. 22 caliber, 20 shots, RF @ 25 yards, B8 target

Match 5. 22 caliber aggregate

Match 6. CF caliber, 20 shots, SF @ 50 yards, B6 target

Match 7. CF caliber, 30 shots, NMC (10shots SF @ 50 yards, 10shots TF @ 25 yards, 10 shot RF @ 25 yards)

Match 8. CF caliber, 20 shots TF @ 25 yards, B8 target

Match 9. CF caliber, 20 shots RF @ 25 yards, B8 target

Match 10. CF caliber aggregate

Match 11. 45 caliber, 20 shots, SF @ 50 yards, B6 target

Match 12. 45 caliber, 30 shots, NMC (10 shots SF @ 50 yards, 10shots TF @ 25 yards, 10 shots RF @ 25 yards)

Match 13. 45 caliber, 20 shots, TF @ 25 yards, B8 target

Match 14. 45 caliber, 20 shots, RF @ 25 yards, B8 target

Match 15. 45 caliber aggregate

Match 16. Grand Aggregate (Aggregate of matches 5, 10, 15).

**AWARDS:** Cash awards only. Any class with less than 5 competitors will be combined with the next higher class. If there are less than 5 high master/master class competitors, they will be eligible for overall awards only. Second place will be awarded if there are 9 or more competitors in a class. Third place if there are 14 or more.
